The company saw the growing numbers of entrapment-related injuries and drownings as cause for serious concern and decided to take action.

“We continued to hear about children being seriously injured and even drowning because drains were not safe,” AquaStar co-founder Olaf Mjelde said. “Well before the Virginia Graeme Baker Act was passed, AquaStar decided to take a proactive approach to safety in and around the pool.”
