Prior to his Senate confirmation as Assistant Secretary of Labor, Rutledge served as senior tax and benefits counsel for the majority tax staff of the Senate Finance Committee. He was the staff lead for Chairman Orrin Hatch (R-UT) on retirement, insurance and employee benefits taxation. Earlier in his career, Rutledge served as a tax law specialist and management official at the Internal Revenue Service.

Rutledge holds degrees with high honors from the University of Idaho (B.S.), The George Washington University Law School (J.D.) and the Georgetown University Law Center (L.L.M. - Taxation). Prior to law school, he served as an officer in the U.S. Navy.
